

FunFest 2025 Public Speaking Competition Rules Middle School



Objective: To encourage students to improve their ability to present themselves and communicate better with others through competition.

Entries and Judging

Participants: MCS has a maximum of thirty (30) entries for Middle School. Teams may consist of 1 to 2 individuals.

Submission: No pre-submission

SCC Judge: Maggie Bozovich, Instructor, Communication

Judging Location: Logan Hall, Room 109

Notes: None.

Determining the winner: Judges will evaluate the speech using the provided rubric.

Competition Rules

The speech should be 2 to 3 minutes in length (no time warnings will be given) and must be developed from one of the following topics:

- The importance of kindness
- How does bullying affect a person's self-esteem
- What does good leadership look like?
- Is it important to have Diversity & Inclusion in middle school?
- What is effective teamwork?

3 minutes is the maximum time for a team presentation, the judges will stop teams at the 3-minute mark if they are still presenting.

- The participant may use notes or note cards.
- Each individual speech must be the result of its own independent work.
- The student members, not the teachers, must prepare presentations and speeches.
- 1 visual can be used, but no props, no PPT's, no electronics
- Students must be in professional dress

FunFest Public Speaking Rubric

Speaker: School:	
I. INTRODUCTION (2 pts. each) Greet, give name, and hook the attention of audience Provide relevancy for audience by "answering" their "what's in it for me" (WIIFM) to hear speech Establish a personal connection to the topic or credibility through experience or education in the topic State a thesis and give a preview of main points Transition into first main point	/10 pts
II. BODY Provide variety of evidence (10 pts. total): Avoid fallacies (-5 points for each fallacy used) Give in-speech references to 3 sources and qualify them as needed (30 pts. total) Have a clear organizational structure as cause/effect, problem/solution, or "Motivated Sequence" and logically / smoothly transition between main points (5 pts.)	/45 pts
III. CONCLUSION Transition into conclusion with a review of the thesis and summary of main points (4 pts.) Deliver strong and viable "call to action" (5 pts.) Express simple gratitude to end speech (1 pt.)	/10 pts
IV. DELIVERY (1 pt. each) Nonverbal behaviors are purposeful (gestures, facial expressions, body movements, etc.) Volume of voice is easily heard Rate and tempo match speech content Inflection is varied Eye contact is sustained with the camera Filler sounds or words are not distracting (ums, ahs, OKs, you knows, and likes, etc.) Poise is maintained if mistakes are made Notes are glanced at and NOT read word-for-word Words and names are correctly pronounced and enunciated Environment facilitates a polished and professional demeanor	/10 pts
